depending on size of Rackrail)

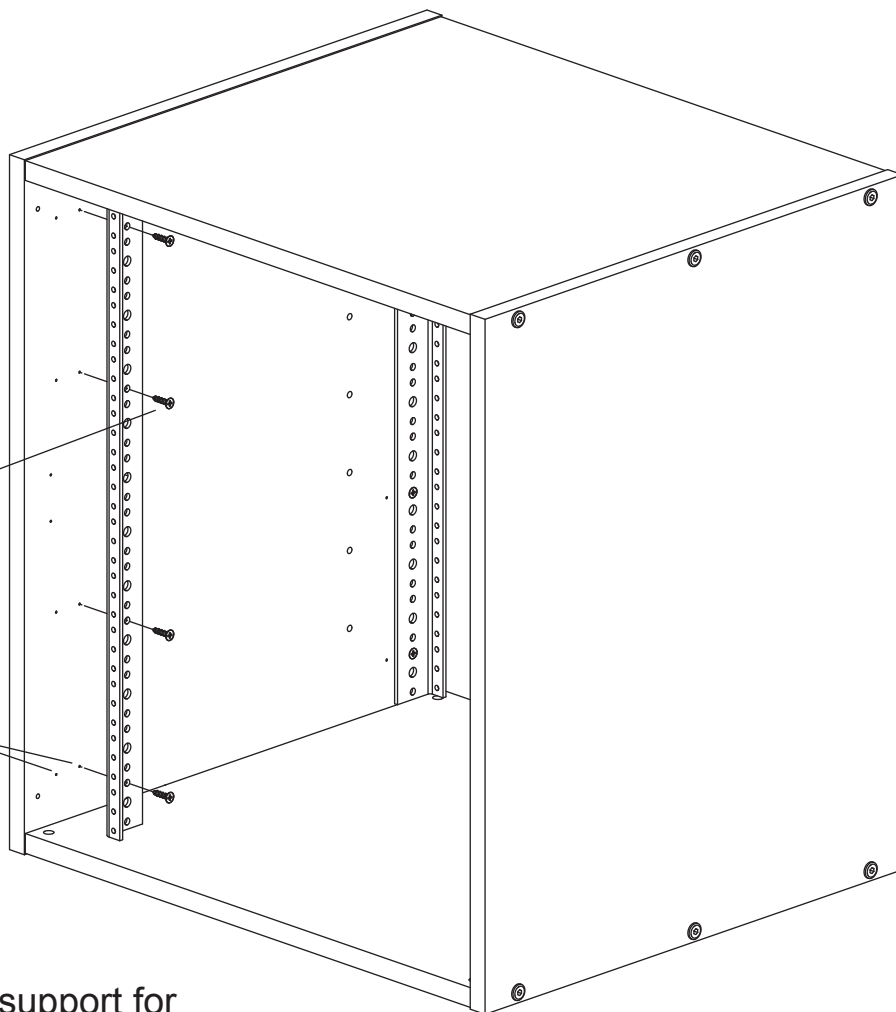
TIP: Installation is easier prior to assembly of rack, but Rear Rackrail may be installed after assembly if necessary.
